Applications, changes due December 12

On January 1, employees who previously waived coverage can enroll in the group plan by completing an **Anthem Enrollment Application** (available from the primary contact at your group) and emailing or faxing it to ISMA Insurance Agency for processing.

Insured employees who previously waived coverage for dependents can add them by completing an **Anthem Enrollment Application** (available from the primary contact at your group) and emailing or faxing it to ISMA Insurance Agency for processing. **All requests for January 1 changes should be submitted by December 12 to allow time for processing.**

HSA 3300/6000 medical plan benefit changes

To comply with federal statutes, effective Jan. 1, 2026, the deductible for the current HSA 3300/6000 plan will be raised from \$3,300 per person to \$3,400 per person. The out-of-pocket maximum will also be raised from \$3,300 per person to \$3,400 per person. The maximum family deductible and maximum family out-of-pocket will remain at \$6,000. The plan name will be changed from HSA 3300/6000 to HSA 3400/6000 to reflect this change.

Anthem ID cards

Anthem will issue new Anthem ID cards in late December *only* to subscribers who change medical plans or add dependents.
